
A good November to all of our neighbors! Your board has been busy in the last month and there is much to report.

Our Roads Committee is now in the later stages of preparing for a presentation and proposal at our upcoming annual meeting. There has been a good deal of study of the various options for our roads and the board has authorized the hiring of an experienced consultant to guide us through the decision process, the bidding and the final choices. Our goal is to have the roads in a condition to last for many years.

As I write this, we are awaiting the Halloween Party and I can assume that it will have been a great success. Planning is now underway for the December Holiday Party as well. Yvonne and I will look forward to seeing you all there. There will be an announcement forthcoming in the next newsletter.


Welcome to the Pueblo Rob & Jeanie Girman

"Rob and Jeanie Girman are the new owners of 2725 E. Avenida de Posada. They've been married for 12 years and live in Northeast Ohio.



Stevie was well known for his quick wit, his contagious laugh and joyous outlook on life.

He was born on April 21, 1944 in San Mateo, California and grew up in southern California. He graduated from San Jose State University and then served in the Air National Guard

NOVEMBER Frost: Watch for frost/freeze warnings. Locate and sort frost covers. Cover non-natives when 32° is predicted. Bring potted succulents indoors. Also: Further reduce irrigation. Last chance to sow wildflower seeds. Harvest your Mexican limes

> Potted annuals for winter sun: Alyssum, Christmas cactus, geraniums, pansies, snapdragon, stock, and violas.

Potted annuals for winter shade: Cyclamen, primrose, lobelia, acanthus.

Winter vegetables for the garden: broccoli, cabbage, cauliflower, lettuce, spinach, chard.

ART in the GARDEN

The desert doesn't offer the North's non-stop panoply of herbaceous perennial bloom. While some desert wildflowers race into brief but effulgent bloom, most native plants cautiously parcel out one or a few blossoms at a time. No matter how the gardener plans, these cycles make our desert gardens alternately flush with color and flowerless.

One strategy for visual interest during the down times — especially appealing in winter, when we spend more time outdoors — is the addition of art to the garden. Stone, metal, tile, and glass endure the elements, but even friable materials like wood can enliven a well-protected porch. Our pueblo gardens would make awkward homes for Grecian goddesses or Roman heroes. But art can take subtler forms and suit the mood of any garden: free-standing sculpture or wall plaque; dignified or whimsical; strictly ornamental or practical; modern or traditional; foreign ethnic souvenir or local; even "found" objects. Around the neighborhood, there is a lovely selection of sculpture that expresses the varied interests and histories of our homeowners. As we approach the holiday season, we are often called upon to entertain, or to attend holiday potlucks and are asked to bring something to share. This recipe was a favorite of my mothers and is a cinch to prepare. It can be molded, as I have shown here, or simply served in a serving dish with a paddle to spread it on French bread or crackers.

Holiday Entertaining

Trader Joe's offers a great selection of 'pop-in-the-oven" hors d'oeuvres, and AJ's has several cases of fine cheeses and prepared foods. This year, make it easy for yourself by purchasing some of these foods, and take the time you would spend in the kitchen to enjoy your friends and family!

Salmon Mousse

I tablespoon butter

I small onion, chopped

I pound cooked skinless salmon filet

I 8-ounce package cream cheese

3 tablespoons lemon juice

I generous tablespoon horseradish

2 tablespoons chopped fresh dill weed

1/4 cup chopped fresh parsley

1/4 teaspoon smoked paprika, or more to taste dash Tabasco sauce

I teaspoon Worcestershire sauce salt and pepper to taste

Melt the butter in a small skillet and add minced onion; cook until onion is clear. Add remaining ingredients and blend with on/off pulses, then run processor until the mixture is smooth. Serve on fresh vegetable slices or mounded as a dip. It also works well on crackers or French bread. Serves 10-12.
