December??? How did it get to be December? On December days in Tucson, it is sometimes hard to think of the Holidays being just around the corner. We are among the fortunate who have to put on sunscreen to put up our holiday lights and decorations. Snow here, rain there and still we have days to sit in the sun.

Some reminders: The Pueblo Holiday Party is on December 10; details are inside the Newsletter. The Annual Meeting of the homeowners is January 10th; details are also inside. Please mark your calendars.

Pool Surveys: Many of you have already returned your pool surveys. These will be due no later than December 4th. While some of you have commented about "rumors" circulating about an intention by the Board to close one of the pools, please be assured that there are no hidden agendas with regard to the survey. Given that the pools are our single largest budget item, the Board felt that it would be a good idea to get some idea about the usage of the pools and particularly to get some ideas concerning suggestions about the pools from those who use it. All of the surveys will be tabulated and the information, along with the submitted suggestions, will be provided at the annual meeting. There is work needed at the pools and the Board has to know how to set priorities for that work.

Roads: Again, this matter will be discussed in depth at the annual meeting but the roads committee has worked hard over the last several months to consider the options, expenses and preferences of the community. The Board has hired a consulting engineer to advise us on the contract negotiations and to suggest ways to achieve the best possible results for the money we spend.

Landscaping: In preparation for the roads project, members of the board have gone through the Pueblo to evaluate any work homeowners might need to do to assure access by the work

crews when work on the roads begins. At the same time, the review has shown that there are a few homes that have some restorative or remedial work to do to bring their visible properties up the general standards of the neighborhood. These homeowners will be receiving informal notes to advise them of work that needs to be done and we assume that when brought to their attention, the work will be done. Generally, of course, as you all know, the Pueblo looks terrific and continues to be a gem of a place to live.

Elections: There are two seats open on the Board of Directors this year. These seats are for three-year terms. Most of you will recall that we re-staggered the terms of board members after the last annual meeting so that there would be future continuity on the Board as terms expired. The report of the nominating committee also appears in this newsletter. One change in Arizona law this year eliminates voting by proxy; all votes must be either in person or by absentee ballot. Ballots along with other Annual Meeting materials will be distributed later this month with instructions for voting absentee.

As the year ends, we are delighted to report that it has been a quiet year in the Pueblo. The Board has put in many hours of volunteer time as have all of the members of the various committees. We have resolved a number of pending issues in the community and have addressed the new issues that have arisen. The books are in order, the budget has worked and the Pueblo is financially sound. Because of the roads fund that has been established over several years, we have no reason to believe that any assessment will be necessary to complete the roads project as it is presently structured. As the contract arrangements are concluded, we will advise you about possibilities for driveway work as part of the project.

Yvonne and I look forward to seeing you all at the Holiday Party.

Lew Daugherty USAF Fighter Pilot 1952 - 1972. Instructed student pilots to fly jets in T-33 trainers. F-100 Flight test pilot & maintenance officer in England, Instructed Vietnamese pilots to fly combat in Skyraider aircraft. Received Silver Star and Distinguished Flying Cross for valor in combat in Viet Nam. Instructed combat crews in F-4 Phantoms at Davis Monthan. Commanded an F4E Fighter Squadron sitting Nuke Alert in Turkey. Home to Tucson to instruct Farm Management at the U of A.

Walter Gaby I was commissioned a second lieutenant in the US Army upon graduating from the University of Arizona, spring 1971. I was assigned a main battle tank platoon with the 2nd Armored Division, Ft. Hood Texas and later transferred to the reserve tank battalion stationed at Ft. Huachuca, Arizona. When I decided to travel to New Zealand in 1973, I became a member of the inactive reserve and was released from the Army in 1986. Luckily I stayed here and went to Germany for temporary duty, avoiding Vietnam.

Fred Frech served in the US Army Corps of Engineers for 30 years, from 1946 to 1976. Much of this time he was overseas, including 9 years in Germany from 1947-1950, 1951-1953, and 1960-1964; 3-1/2 years in Korea from 1955-1956 and 1973-1975; and 1 year on Eniwetok in the Marshall Islands from 1966-1967. His duties included various staff and command positions with engineer troops, other staff assignments related and not related to engineering, one year supervising military construction with the Mobile District of the Corps of Engineers, one year working for NASA at their Mississippi Test Facility, three years teaching physics at West Point, and three years with the Ohio River Division of the Corps of Engineers. He was never in a combat zone because the Army sent him back to Germany during the Korean War and then to Korea during the Vietnam War. Of course he doesn't regret never being in combat, but he feels that he really didn't do his part, having a 30-year, combat-free career while thousands of non-careerists served and suffered in our country's wars.

Marti Greason's daughter, Major Rebecca Brooks is only two years away from retiring from the United States Air Force! She was commissioned through the Reserve Officer Training Corps, Northern Arizona University, Flagstaff, AZ in 1993. As a Communications Officer, she has moved every few years and been stationed in North Dakota, Illinois, England, Las Vegas, Virginia, Iraq and Korea. She is now completing her final assignment in the Defense Information Systems Agency at Ft. Meade, Maryland, in charge of an unclassified information sharing capability that provides U.S. and foreign militaries and U.S. and foreign civilians a way to communicate in support of coordinated humanitarian and disaster relief efforts. Rebecca resides in Laurel, Maryland with her husband, LTC Craig Fleming and her 2 sons, Alex and Chris.



Honoring Our Veterans

Constance Pochyla's husband, Benjamin Henry Pochyla was born in West, Texas, on 16 November 1908. He was graduated from Texas A & M college in 1929, and commissioned a second lieutenant in the Cavalry Reserve. Prior to World War II, General Pochyla was employed as an Industrial Engineer with the Southwestern Bell Telephone Company.

During World War II, he served initially in the Operations Division of the War Department General Staff and, later, as the Deputy Chief Signal Officer on General MacArthur's staff in the Pacific, under the auspices of Colonel Dwight David Eisenhower which led, in turn, to five tours at the Pentagon.

Since World War II, General Pochyla has had staff and command assignments with the following: U.S. Army, Europe; Office of the Chief Signal Officer, Department of the Army; Office of the Deputy Chief of Staff, Logistics, Department of the Army; faculty of the U.S. Army War College; Commanding General, Fort Gordon, Georgia; and, immediately prior to his Fort Huachuca assignment as Commanding General, he was the Deputy Director of Communications-Electronics for the Joint Chiefs of Staff.

Isidore Shapiro I served in the army from 1942-1946 and I was part of the cadre of a five thousand bed hospital system on Tinian in the South Pacific preparing for the invasion of Japan. The atom bomb was flown from this island on the Enola Gay, captained by Col Tibbetts, which ended the war. The bomb was completed while on flight to avoid even the possibility of a premature explosion on the island itself. Imagine - 66 years ago.

Roy Langenberg I was drafted into the U.S. Army in October 1961 during the Berlin Crisis caused by the Russian blockade of Berlin (again). My advanced training was in the Army Intelligence Corps, and I was stationed in Kansas City. My relatively uneventful tour of duty was punctuated by the Cuban Missile Crisis. I was not living on a post and was working in civilian clothes. We were placed on 24 hour alert and had all uniforms ready for intelligence duty with no rank or unit insignias. The orders were classified, but the press became aware of the mobilization because Fifth Army Headquarters in Chicago was fully staffed on a Sunday. It was a tense week for all military personnel.

Bill Ridlinghafer I served in the Air Force for just over 20 years and have been stationed or on temporary duty pretty much all over the world. I have been stationed in Texas, Arkansas, North Dakota, California, New Hampshire, Florida, Taiwan, Thailand and Arizona. I have been on temporary duty in the Azores, England, Spain, Alaska, Thailand several times, Guam, and Cyprus. I was a navigator on KC 135 refueling planes, flight instructor for the KC 135 in California for eight years, staff planner for the U-2 spy plane, and was sent to Taiwan for C 130 duty (we called them trash haulers) right at the end of the Vietnamese war. Then as the war wound down I was sent to Udorn Royal Thai AFB as the deputy base commander. After the years tour of duty in Thailand I decided to retire in Tucson so I got a job as a stockbroker with Merrill Lynch here and have always said that we are very lucky to live in Tucson.

Clean away ground litter from base of plants

Begin harvesting citrus

Bare-root perennials may be planted in December

GLOBAL GARDENS

One of the delights of travel is being a guest in someone else's garden, or, lacking an invitation, sneaking a furtive peek through a gate or over a garden wall. A sense of place is powerfully conveyed by natural scenery, historic architecture, and gardens, the latter signaling locale by traditional arrangements and plant selection. Foreign as these may seem to our local, they may provide inspiration for a detail or problem corner in the home garden. Gardens were once the ultimate symbol of wealth and power. But even for ordinary mortals the urge is irrepressible, whether expressed as a cottage garden, a vegetable patch, in doorstep pots, crates on a roof, or a simple window box. Here are some glimpses we've had of other people's gardens.

Citrus~Ginger~Cranberry Sauce


This is a new take on a holiday tradition - it was a big hit at our Thanksgiving table. And, as so many of us have citrus trees, this is a great way to make good use of the fruit on hand. Remember - cranberry sauce isn't only for Thanksgiving and the December holidays! Have it year round as a chutney or condiment.

Make sure you slice the fruit very thinly and that you get out all the seeds.

Bags of cranberries freeze beautifully for future use!

- 24 ounces fresh cranberries*
- 2½ cups of sugar*
- 1 cup port wine*
- 2 cinnamon sticks*
- ¼ cup crystallized ginger*
- 1 2-inch piece fresh ginger, chopped*
- 1 unpeeled Meyer lemon, quartered lengthwise, seeds removed and thinly sliced*
- 1 unpeeled lemon, quartered lengthwise, seeds removed and thinly sliced*
- 1 unpeeled lime, quartered lengthwise, and thinly sliced*
- ½ cup golden raisins*
- ¼ cup water*

Add all ingredients to a large, tall-sided kettle. Cook over low heat, stirring until the sugar dissolves and the cranberries soften, about 10 minutes. Increase the heat to medium and cook until the cranberries burst about 12 minutes more. Place in bowl(s) and let cool.

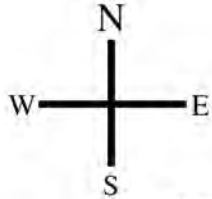
